A course transfer is made available to simplify the process of withdrawing from one course and enrolling into another. Students may request to transfer to a different study mode across Sydney Design School and Interior Design Online or a different course. Students may undergo no more than one transfer during their enrolment. A course transfer is only valid for active enrolments, which excludes enrolments that were cancelled in line with the Course Progression Policy.

At the time of course transfer resulting in a withdrawal from the original course, students incur the cost of their original course as per the Refund Policy. This may result in fees still owing on the original course or a refund available. If a refund is available, this may be transferred to the new course if applicable. No other transfer of fees is permitted. Fees are not transferrable to another student. If a student transfers into a course or study mode with a higher cost, they will be charged the balance of fees.

Students incur the cost of their original course in line with the Refund Policy. Fees are transferrable to another course only if the student is eligible for a refund upon withdrawal from the original course. Fees are not transferrable to another student. If a student transfers into a course or study mode of a higher cost, they will be charged the balance of fees.

Students may request to transfer into a different study mode to continue their current course. Students must contact the enrolment team first to discuss their circumstances and options. Requests to transfer into a timetabled class (on campus or Virtual Studio) are not guaranteed. Students will be waitlisted for their desired class and, if available, offered a place one week prior to the start of class. If a place is not available to be offered to the student, the student can choose to continue their course in their original study mode or withdraw from their course.

Students may transfer from a course with a higher AQF level into a course with a lower AQF level, for example from the Diploma of Interior Design into the Certificate IV in Interior Decoration. This is applicable if the student has decided they do not wish to finish the full qualification of their original enrolment.

To transfer, students must complete a Course Transfer Application from the Student Hub on the eCampus. This will be processed within 3 business days.

If the transfer requires the student to enrol into a new course, any special considerations and conditions provided to the student will be valid for 6 months. After that time, if the student wishes to enrol, they will be able to do so in accordance with the Re-enrolment Policy.
